

Use of the Form of Exercising the ARCO Rights

The reason of including this form (see page 2) is due to improve the communication and help your request management of exercising the ARCO (Access, Rectification, Cancellation and Opposition) Rights as it is established by the Spanish Organic Law of Data Protection 15/1999

The form allows to indicate your choice:

- ✓ **Exercise the Right of Access:** Communicate the data that have been saved about you, derived from forms, communications and commercial relationships which could establish between the parties.
- ✓ **Exercise the Right of Rectification:** Determined this form so that you can notify formally the data which do not correspond to you, or those ones which you want to rectify or modify.
- ✓ **Exercise the Right of Cancellation:** In the case that you want us to delete or cancel the data saved about you, derived from the forms, communications or commercial relationships established between the parties.
- ✓ **Exercise the Right of Opposition:** In order to delimit the purposes or data usage, for which you provided your consent, notice that the commercial relationships, advertising or informative (newsletters) have as purpose to allow the exercising of right of opposition directly = see in the email the option "unsubscribe".

Procedure to use that form:

Postal Mail Notification:

- Fill it in
- Attach ID copy

Additional Information:

According to the Spanish article. 17 of the LOPD 15/1999 where they are determined the procedures to exercise the rights of option and access, as well as the rectification and cancellation ones (ARCO) will be established in due form. In the art. 24, of the regulations 1720/2007 which the LOPD develops, the general conditions are established for the exercise of the ARCO rights [are independent rights. They will be granted to the applicant simply and freely as possible. The file person responsible must attend the request made by the applicant even when s/he had not used the established procedure specifically by that one, providing that the applicant has used means which allow to confirm the shipment and delivery of the request and that this one has the elements stated in the paragraph 1 of the article 23. In the article 25 the procedure of exercising is established [the exercise of the rights must be carried out by means of a communication sent to the File Person Responsible which will have; the applicant's Name and Surname, ID copy or equivalent document, and in other case, the legal representative's or equivalent electronic instruments, as well as the document or electronic instrument confirming that representation. The use of the electronic signature will exempt the copies submission. The person responsible of the treatment will have to answer the request which is sent in any case, independently that his/her data appear in the files].
